ABOUT THE CONTRIBUTORS

Kate Bayliss is a Senior Research Fellow at the University of Sussex and Research Associate at SOAS and University of Leeds. Since completing her PhD in Development Economics at SOAS, she has worked on issues relating to social equity and the provision of infrastructure and essential services in the United Kingdom and the Global South. Her particular research interests are on the changing paradigms surrounding private sector engagement in meeting basic needs and on the distributional outcomes from such interventions. She has worked in academia as well as consultancy for civil society organizations, trade unions, and UN agencies. She has published articles in *World Development*, *Competition and Change* and the *Journal of Development Studies*. Her recent research focus is on the role of systemic issues in the provisioning of economic and social infrastructure.
